Alan Reich and the National Organization on Disability has asked if you will co-sponsor a Congressional briefing on the results of a new survey of people with disabilities, which updates the groundbreaking 1986 Louis Harris/ICD Survey of Disabled Americans. This briefing will be held on Thursday, July 21, in SC-10, at 3 p.m.

- Senator Harkin has agreed to sponsor this briefing as well; if you agree, invitations to Senate colleagues will be sent jointly.
- N.B.: As you may recall, the 1986 Harris data was at the heart of your statement on crime and disability -- it found that people with disabilities ranked fear -- fear of being hurt, fear of being a crime victim -- as the number one reason why they do not socialize as often as other americans -- whether going to the movies or visiting with friends. Architectural barriers were ranked these barriers only fifth why they don't go out more. I requested an advance copy of the NOD survey results -- they might make an interesting floor statement.
